

The Transformation in scholarly publishing: Research integrity and publication ethics

The Japan chapter of the International Association of Scientific, Technical and Medical Publishers (STM) and the Japan Science and Technology Agency (JST) will be holding a joint seminar on October 21st, 2019. The seminar will explore a variety of topics around research integrity and publication ethics, bringing together funders, academics, governments representations and those with an interest in scholarly publishing.

The morning session, hosted by STM will examine the growing need for higher and more transparent ethical standards in scholarly publishing. It will cover issues such as conflicts of interest, ghostwriting, guest authorship, citation rings, peer review rigging, authorship disputes, falsification and fabrication of data, scientific fraud, unethical experimentation and plagiarism. The afternoon session will be hosted by JST and will be focused on publication ethics, with the presenters sharing trends and insights in publication ethics, and exploring the mission and strategies of two industry initiatives: COPE and JAMJE. In addition, case studies related to guidelines produced by COPE and JAMJE will be presented by Japanese learned societies.
