Dear OSTP Open Science and Accessibility Teams,

STM and its members are committed to expanding access to scientific and technical publications, aligning with the goals of the OSTP. Two of our established committees, the STM Social Responsibility Committee and the STM Standards and Technology Committee, have integrated accessibility into STM policies and workflows. We look forward to continuing our partnership with the OSTP and federal agencies on initiatives related to public access and accessibility.

Our members have a long-standing commitment to digital accessibility for the content they produce and disseminate. This has been a priority since the advent of the digital age. The launch of the <u>Charter for Accessible Publishing</u> has seen STM publishers adopt eight key principles, including the appointment of a senior manager responsible for overseeing accessibility and monitoring progress in this area. This initiative aims to ensure a comprehensive commitment to meeting the community's needs, including adherence to the Americans with Disabilities Act and the European Accessibility Act, as well as addressing various other requirements and requests.

We therefore wholeheartedly support OSTP's "Voluntary Commitments to Improve the Digital Accessibility of Scientific and Technical Publications." Many STM members have signed up for the <u>Publishing Accessibility Action Group Charter</u>, which has committed them to several actions that align with the OSTP's voluntary commitment.

Whilst STM itself is not an information provider, we support our membership in our mission to "Advance Trusted Research," including by promoting accessibility. Our contribution to the voluntary commitment will be to support our members to increase the digital accessibility of the resources they provide through information sharing and standards. This aligns most closely with OSTP's priority #2: "Promoting awareness of barriers to digital accessibility, advancing training to reduce such barriers, and increasing accountability for improving the digital accessibility of scientific and technical publications," but also will address Priority Area 1 items to both "Collaborate across the research and scholarly communications ecosystem to share resources and best practices for meeting WCAG 2.1" and "support establishment," "design and developments," and "a positive culture" for digital accessibility.

By the end of January 2025, STM will launch an accessibility resource web page designed for our members and the wider scholarly communication community. This resource aims to support efforts to enhance digital accessibility for their products. STM members actively engage in national trade association working

groups and collaborate with library partners to stay informed about relevant regulations and effectively implement them.

The purpose of the resource page will be to provide general information on accessibility and related policy/regulations, share best practices and examples that publishers can learn from, and inspire additional action from members and others. One example is <u>Benetech's Global Certified Accessible</u> program, where many STM members have used third-party certification programs.

The general information section will cover several important topics, including:

- Accessibility Primer
- International Regulatory and Policy Information
- Links to Standards and Tools
- Publisher and Publishing Platform Organization Accessibility Statements
- List of International Working Groups and Links

STM's resources will also be supported by webinars and other in-person-person events to perpetuate its utilization, building on STM and our members' ongoing activity on accessibility, and we are also well positioned to help amplify and share different approaches across its global membership, working closely with others like <u>Association of American Publishers</u>(AAP) and the <u>United Kingdom Publishing Association</u>(UK PA) to support global alignment.
